
SM Small thanked all for the help in the installation.

SM Small said that he planned on conferring the degree of Knight of Constantinople this year.

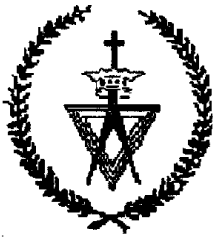
A motion was made, seconded and passed to make a \$25 donation in memory of Scott Dalton to a scholarship fund established for his children.
