Granville McVey having accepted the invitation and their fees having been paid, were announced in waiting and were admitted and received into membership in Jesse Green Priory No. 70. The Ceremony of Reception was conferred by Em. Prior Hutchins assisted by the other officers, with the lectures being given by Donald D. Thomas, KYGCH - LODGE; Walter D. Wagner - CHAPTER; T. With P.P. and M.W.G.M. Law acting as Installing Officer and P.P. C. Ray Scarborough as Installing Marshal, the following officers were installed:


