The Eminent Prior expressed his sincere appreciation to those in attendance for joining with him for this Special Conclave of the Priory.

At the request of the Prior, the Registrar presented the minutes of the January 29, 2000 meeting, wherein our distinguished Brother Maurice C. Barnes was received into the Priory, in brief and accepted as such by those in attendance.

The Registrar also presented his financial report for the year which showed:

The receipts include \$19.33 in interest. In addition, the Priory has a \$1000.00 CD invested with Wilmington Trust maturing on October 20, 2000. The Treasurer's report was accepted as presented.

The Registrar then reported that he was in receipt of a Proposal for Membership for James Thomas Elliott, Jr., who was Master of St. John's Lodge Number 1 in 1988, High Priest of Delta Chapter Number 6 in 1993, Illustrious Master of Gunning Bedford Council Number 1 in 1994 and Eminent Commander of St. Johns Commandery Number 1 in 1999. The Registrar finding the proposal well in order moved that our esteemed Brother James Thomas Elliott, Jr. be given the benefit of the ballot. Such being duly seconded and approved, the ballot was spread and found to be favorable. The Prior then requested that Knight Eugene R. Small be in

contact with Brother Elliott and, if he finds within him a favorable disposition to join the Priory he present him with an Acceptance of Invitation Form. Knight Small accepted this duty with great pleasure.

The Prior then requested the attached summary of the financial posture of the evening of Masonic Enlightenment held on February 29, 2000. In brief, total income from 185 ticket sales and the sale of 30 books was \$3,096. Expenditures were \$1,921.45 including \$1,387.59 for the dinners. The net gain of \$1,174.55 was derived from \$56.05 from the limited book sale and \$1,118.50 from the meeting dinner. It should be noted that the transportation expenses for Dr. McLeod from his home in Canada to the meting and return were donated by the Prior. In addition, there were no housing expenses as the Prior also graciously welcomed Dr. McLeod into his home.

The Prior then noted that on all previous occasions wherein the Priory had realized a profit from their Masonic Enlightenment Programs, they had distributed a portion of this profit back to the fraternity and/or community. Such being the case the Prior opened the floor to suggestions on the disbursements of the profits from this evening. It was decided that the following distributions would be made:

\$100.00 to Five Points Chapter, OES as a token of our appreciation for their assistance with the meals of the evening.

\$100.00 to Convent General's York Cross of Honour Medical Research Foundation in the name of Dr. Wallace McLeod.

\$300.00 to the Masonic Home of Delaware in such a manner to be subsequently determined.
